

This subsidiary aims to improve the quality of healthcare services and medical research within and outside South Africa's borders.

**Numolux Clinical Research:** We have reached many milestones with this unit of our health portfolio. In particular;

- Through our partnership with Chinese pharmaceutical giant Sinovac Biotech we successfully carried out paediatric clinical trials with the inactivated CoronaVacvaccine (which was administered to over 2.8 billion people) and vaccinated the youngest-ever child in the world. That baby was 6 months old at the time (November 2021) and thus far, shown no serious adverse effects.
- With our series of international health seminars, called "BRICS and Africa: Africa's Solutions to Africa's Health Challenges" we brought together thought leaders and experts in the medical, and pharmaceutical industries from BRICS and African countries and delved into issues which continue to plague the Global South, namely; Malaria, Non – Communicable Diseases, Regulatory Harmonisation and Mental Health and Wellness.



- Our international sales program envisions to include buyers from Egypt, Kuwait, other North African Regions, Russia and China.






